GENERAL EXHIBITION CONDITIONS

- **The organizer of the AGRO ARCA 2024 fair is the Croatian Community of Innovators, in accordance with the rules of IFIA - International Federation of Inventors' Associations, with the support of the Croatian Association of Technical Culture.**
- 1. The General Terms and Conditions apply to all exhibitors.
- 2. The right to participate in the fair is granted to legal entities and individuals in accordance with the General Terms and Conditions of Exhibition.
- 3. At the AGRO ARCA 2024 fair, innovations in agriculture, the food industry and agricultural mechanization, as well as new products and technologies from the fields of mechanical engineering, electrical engineering, information technology, physics, mechatronics, chemistry, biology, medicine and other natural and technical fields related to agriculture are permitted to be exhibited.
- **4. Applications for participation are accepted no later than September 20th, 2024 at 4:00 p.m.**
- 5. Applications received after the deadline specified in point 4 of the General Terms and Conditions of Exhibition will be rejected.
- 6. A validly submitted application is also considered a contract concluded between the exhibitor and the organizer by which the exhibitor confirms that he accepts the terms and conditions of the exhibition. The exhibitor is obliged to sign the application in person, and if the exhibitor is a legal entity, he is obliged to certify the application with a seal. In the case of filling out the application on the online form, it is valid without a seal and signature and by filling it out, the exhibitor accepts the exhibition conditions.
- 7. The minimum exhibition space per innovation is 2 m², except in the case of exhibition space TYPE A where one innovation is on 1 m².
- 8. After receiving the application, the organizer will issue an offer to the exhibitor for the ordered services. The exhibitor is obliged to make payment according to the offer no later than **October 8, 2024 at 4:00 p.m.**
- 9. By making the payment according to the offer, the exhibitor secures his exhibition space.
- 10. If the exhibitor does not make the payment within the deadline specified in t. 8 of the General Exhibition Conditions or by the specified deadline notifies the organizer that he/she is withdrawing from the exhibition, the exhibitor will not be provided with an exhibition space and is obliged to pay the organizer 75% of the price of the ordered exhibition space.
- 11. If the exhibitor cancels participation in the exhibition outside the deadline specified in t. 8 of the General Exhibition Conditions, he/she is obliged to pay the organizer the full price of the ordered exhibition space.
- 12. The organizer undertakes to complete the technical part of the preparation of the exhibition space by **9 October 2024 by 3:00 p.m.**
- 13. The exhibitor may begin work on arranging his/her exhibition space on 9 October 2024 from 3:00 p.m.
- 14. The exhibitor is obliged to equip the exhibition space with exhibition content on the day of the official opening of the fair, no later than 9:00 a.m. **The official opening of the fair will be held on October 10, 2024, starting at 11:00 a.m.**
- 15. In the event of an exhibitor's request for additional work, equipment or furniture on the exhibition space, the organizer will charge the exhibitor for the same in accordance with the applicable price list.
- **16. The exhibitor is not allowed to remove exhibits from his exhibition space before the official closing of the fair, which will be held on October 12, 2024. at 4:00 p.m. The exhibition's opening hours are from 10:00 a.m. to 6:00 p.m. for visitors and from 9:45 a.m. to 6:15 p.m. for exhibitors.**
- 17. The organizer provides security services during the fair, but is not responsible for damage, loss or alienation of the exhibitor's property occurring during the fair's opening hours.
- 18. During the fair, exhibits will be evaluated and the most successful exhibitors and exhibits will be awarded prizes and awards in accordance with the AGRO ARCA Prizes and Awards Regulations.
- 19. The organizer is responsible for maintaining cleanliness between the exhibition spaces, and the exhibition space itself is maintained by the exhibitor.
- 20. The prices of the exhibition space are stated without VAT, pursuant to Article 90, paragraphs 1 and 2 of the VAT Act.
- 21. The exhibitor and the organizer will try to resolve any disputes amicably, and if they fail to do so, they will determine the jurisdiction of the court in Zagreb.
